

**COPPER BASIN UTILITY DISTRICT  
REQUIREMENTS FOR RENTAL CUSTOMER**

I \_\_\_\_\_, HAVE PUT UP A \$150.00 (ONE HUNDRED FIFTY) NON-REFUNDABLE SERVICE CHARGE AND UNDERSTAND THAT I WILL BE RESPONSIBLE FOR THE BILL TO BE PAID MONTHLY.

THE FOLLOWING ARE THE RULES AND REGULATIONS OF THE COPPER BASIN UTILITY DISTRICT.

1. ONLY ONE DWELLING IS ALLOWED PER METER. YOU ARE NOT ALLOWED TO CONNECT ANY RENTAL PROPERTIES (CAMPERS OR ANY OTHER DWELLING) TO YOUR DESIGNATED METER.
2. WATER BILLS WILL BE SENT BEFORE THE FIRST OF THE MONTH AND DUE BY THE FIFTEENTH OF THE MONTH.
3. IF NOT PAID BY THE FIFTEENTH OF THE MONTH PENALTIES WILL BE ADDED.
4. IF PAYMENT IS NOT MADE WITHIN TEN (10) DAYS, WATER IS SUBJECT TO DISCONNECTION FOR NON-PAYMENT.
5. TO RECONNECT WATER AFTER BEING DISCONNECTED DUE TO NON-PAYMENT, A \$50.00 (FIFTY DOLLAR) RECONNECT FEE WILL HAVE TO BE PAID IN ADDITION TO THE BILL BEFORE WATER SERVICE CAN BE RECONNECTED.
6. IF WATER HAS BEEN DISCONNECTED BY THE UTILITY FOR ANY REASON SUCH AS NON-PAYMENT OF THE BILL, THE METER IS NOT TO BE TURNED BACK ON BY ANYONE OTHER THAN A UTILITY EMPLOYEE. IF THIS HAPPENS YOU MAY BE SUBJECT TO A THEFT OF SERVICE FINE AND THE METER MAY BE PULLED.
7. IF THERE IS A WATER EMERGENCY AND YOU NEED ASSISTANCE YOU MAY CALL 423-496-5744 DURING WORKING HOURS OR IF IT IS AFTER HOURS OF THE COPPER BASIN UTILITY, YOU CAN CONTACT 423-241-9449 (OR )423-241-3748 (OR) 423-241-7532 AND SOMEONE WILL BE ABLE TO GET YOU SOME ASSISTANCE.
8. IF WATER IS DISCONNECTED DUE TO NOPAYMENT AND IT IS AFTER HOURS OF THE COPPER BASIN UTILITY DISTRICT OFFICE, THE EMERGENCY NUMBERS LISTED ABOVE WILL NOT BE ABLE TO ASSIST YOU. YOU WILL HAVE TO WAIT UNTIL THE NEXT WORKING DAY, WHICH BEGINS AT 8:00 A.M.
